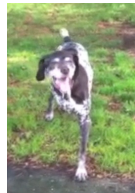

Happy Savu



Savu, an 8-year old German Shorthair, was diagnosed with a bone tumor last November. He was in great pain and couldn't use his right forelimb. Using our Fuji Digital X-ray system, we imaged the limb and diagnosed the tumor. Unfortunately, most bone tumors in dogs are treatable only with amputation and chemotherapy. Dr. Flecker and Dr. Holter amputated Savu's leg later that week. Now, Savu's back at the park playing catch.
